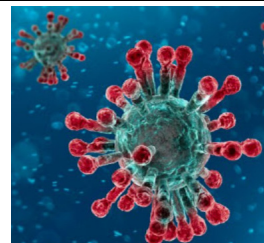

SAFETY MEASURES AND HYGIENE PRECAUTIONS

- For the opening and closing times to the public, timing of the individual sections and methods for getting in and out of the cabins, the company website must be consulted in advance <http://www.funiviedellagomaggiore.it/>
- As per regional ordinance no. 566 of 12/06/2020 it is mandatory to show up and wear disposable gloves and surgical mask from the moment you enter the station, stop at the stops and queue for boarding the vehicles, until the moment you leave.
- Suitable dispensers containing hand sanitizing solutions are available. It is recommended to use it before entering the cabin.
- The cabins can accommodate one person per way, maximum two if they come from the same housing unit.
- It is recommended not to show up with body temperature above 37.5 °
- Possibility of detecting body temperature and mandatory removal in case of exceeding 37.5 °
- Self-certification form of family origin is available online. We recommend that you fill in the estimate before purchasing the tickets.
- In all company spaces, the limit of one meter of interpersonal distance must be respected, excluding people who live in the same housing unit.
- It is preferable to use contactless payment methods instead of cash.
- The use of lifts is limited only to people with walking difficulties.
- The transport of scooters, folding bicycles and other electric micro mobility devices is allowed.
- Both in the entry and exit phases, it is necessary to respect the signs shown, always keep the social distance of one meter and the prohibition of assembly between the two flows.
